

HIGHLIGHTS OF THE PAST YEAR

- Massive revision to website. In addition to explaining our mission and purpose, our site publicizes and promotes:
 - Events sponsored by Tysons Interfaith and area non-profit organizations.
 - Direct links to community services and Fairfax County resources, as well as public health resources to combat the Covid virus.
 - Links to area faith communities, non-profits and volunteer opportunities.
 - Inspirational and informative blogs.

2021 the new web site has had over 25,800 visits, averaging almost 1000 visits per week!

Panel presentations and group discussions. Unable to continue our Community Conversation series in person because of the pandemic, but outraged by the public murder of George Floyd and other people of color, we pivoted to Zoom to conduct discussions on the "oneness of humanity." The series began with a theological perspective and evolved into discussion of practical actions we all can undertake.

- Theological foundation from several faith perspectives.
- Different faith perspectives on "racism."
- O What are we learning about social justice inequities during the pandemic?
- What specifically can people of faith do to encourage dialogue and encourage social justice?
- o Social justice issues in Tysons from the perspective of District Supervisors Palchik and Alcorn.
- O What makes a community a community?

Over 200 different attendees participated in seven discussion sessions

- ➤ Growing our presence and understanding our Tysons Community. Most Tysons Interfaith and community events were conducted virtually this past year. While this did not allow us to build relationships in person, virtual attendance did have many benefits, such as reaching many more people; not having to find and reserve meeting or event venues; eliminating traffic and parking issues; and beginning and ending on time, to name a few. As a result, a larger number of Tysons Interfaith members were able to attend advocacy, County-sponsored, and educational opportunities than otherwise would have been the case.
 - Dialogue with Community Leaders
 - Tysons falls in two Fairfax County jurisdictions Providence District and Hunter Mill District. Supervisors Palchick (Prosperity) and Alcorn (Hunter Mill) participated in our Oneness of Humanity discussions, sharing their views on needs in the current and future Tysons and the role of faith communities. We continue an open dialogue with these Supervisors and their staffs.
 - Partnership CEO Sol Glasner met with the Tysons Interfaith Board to discuss Tysons as a "community." He considers Tysons Interfaith to be a bridge between the government sector, private sector (investors), and residents. Sol noted that:
 - Tysons is successful economically but lacks "soul." He encouraged us to continue
 developing "spiritual space" in Tysons, whether it be physical space or a spirit of
 community respect and service.
 - A mature urban community must have space available for worship and meditation, for those who wish to do so.
 - Pursuing shared space with the arts community may be a viable option and prove beneficial to both the arts and faith communities.
 - We should build a close relationship and expand our work with the Partnership's Community Responsibility Council.
 - Fairfax County Equity Officer, Karla Bruce, met with us virtually to review the Fairfax County Strategic Plan and the County's Equity Statement.
 - Kim Bobo, Executive Director of the Virginia Interfaith Center for Public Policy, and Northern Virginia coordinator, Anne Murphy, met with our Board to explain the VICPP mission and how people of faith can influence state policies and legislation.

- Mentored the Capstone project for a George Mason University student researching healthcare disparities in Fairfax County.
 - She concluded that residential zip code does in fact influence availability of healthy foods, healthcare, and healthcare outcomes even here in Fairfax County.
- Several Tysons Interfaith members and congregational representatives
 participated in on-line events sponsored by Faith Communities in Action (FCIA),
 the liaison between the County's nearly 500 faith communities and County
 government. FCIA works to increase awareness of community services and
 resources, identify needs, and strengthen community capacity to meet those
 needs.



- Recurring periodic sessions on health care and County resources to deal with the Covid pandemic.
- Service opportunities to assist with food and housing emergencies suffered by County residents suddenly unemployed because of Covid lock downs.
- Social justice issues in the County and remedial actions planned or underway.
- Training curricula for County police officers on equity in law enforcement.
- Vocational training opportunities in Fairfax County.
- Besides reaching out to the community beyond our congregations, Tysons Interfaith is a way for faith groups to get to know, understand, and respect one another, and promote good feeling among congregations of all faiths, despite doctrinal and other differences. Tysons Interfaith was delighted to welcome three new participating congregations during 2020-21.

OUTREACH

- In partnership with Fairfax County as a public service, completed and published a map of houses of worship, public spaces, and community services available in and within a five-mile radius of Tysons.
- Through our website and direct emailing spread the word and encouraged support of emergency feeding for families and individuals suddenly made food-insecure by loss of jobs and closed workplaces.
- Prepared Welcome Bags for new residents in Tysons. Bags contain the Community Map, pens, refrigerator magnets, eyeglass cleaners, and a welcome note from Tysons Interfaith, all bearing the Tysons Interfaith logo and encouraging newcomers to visit our website.

> FUTURE

- o Essay contest. We are sponsoring an art and essay contest in fall 2021, with cash prizes, inviting students and adults in the Greater Tysons area to share emotions and perceptions as to how they have been impacted by the reality of living in a pandemic world. Depending on community response, this may become an annual event, on different topics.
- o The Oneness of Humanity discussions will resume in September 2021, with a panel presentation and discussion on mental health issues associated with lifestyles, health concerns, and political tensions we are all experiencing.
- We are exploring ways Tysons Interfaith can provide long-term support for Afghani refugees who will be settling in Fairfax County, seeking guidance from our Muslim faith communities, Lutheran Social Services, Fairfax County, and others involved with resettlement efforts. We are considering hosting a Oneness event to hear directly from Afghani refugees about their experience and to highlight ways individuals and faith communities can help them.
- o We are exploring options for a "Meet Your Neighbor" event, a community gathering that celebrates the diverse cultures present in and essential to our vibrant Tysons community. We seek partners in both the non-profit and corporate communities to ensure success of this event.
- Many new indoor and outdoor venues have opened throughout Tysons, offering Tysons Interfaith
 comfortable places to gather for discussion, special programs, and building relationships of mutual
 respect
- We have transitioned probably permanently to Zoom for monthly meetings but have begun scheduling quarterly after-work social events to maintain personal contact.
